COMPULSORY COURSES

YDİ- Foreign Language (4-0-4) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: Foreign Language is a course that offers social work students the opportunity to improve their language skills and gain the ability to be effective in international communication. This course aims to strengthen students' reading, writing, listening and speaking skills in a foreign language. At the same time, it aims to provide students with competence in following international literature in the field of social work, interacting with cultural diversity and understanding different languages and cultures. The IWL course aims to contribute to the professional development of social workers. Skills such as understanding and participating in social work practice in the international arena, using language skills effectively in social work practice, being successful in intercultural communication and developing sensitivity to social problems at the international level are emphasized in this course. The FFL-Foreign Language course aims to provide social work students with a global perspective and a foundation for becoming effective social workers in the international arena.

Teaching Method(s): Online

Assessment Method: Midterm exam (40%), final exam (60%).

Language of Instruction: English

DIJ111-Digital Literacy (2-0-2) ECTS 3

Course Level: Undergraduate

Course Type: Compulsory

Course Content: DIJ111-Digital Literacy is a course that aims to develop social work students' ability to understand and effectively use digital technologies, gain skills in accessing information, and act ethically in online environments. This course provides students with the opportunity to understand the impact of contemporary communication tools and digital media on



social work practice. Digital Literacy aims to provide students with the skills to critically evaluate digital resources, engage in digital interaction, be aware of digital safety issues, comply with online ethics, use digital media tools effectively, and create digital service offerings. Topics emphasized in this course include digital literacy skills such as social media management, online ethical responsibilities, collecting and analyzing data from digital sources, online privacy issues. Digital Literacy course aims to help students adapt to contemporary social work practice by supporting social workers to communicate effectively in today's digital age, provide digital services to clients, and act ethically on various digital platforms.

Teaching Method(s): Lecture, question-answer

Assessment Method: Midterm exam (40%), final exam (60%).

ENF101-Basic Information Technologies (2-0-2) ECTS 2

Course Level: Undergraduate

Course Type: Compulsory

Course Content: ENF101-Basic Information Technologies is a course that aims to provide social work students with the skills to understand, use and effectively apply basic information technologies in the field of social work. This course provides students with the opportunity to understand the role of information technologies in social work practice, to use digital tools effectively, and to become aware of information management and data security issues. Basic Information Technologies course aims to provide students with basic information technology concepts, office software, internet-based tools, database management, information security and ethics. Topics emphasized in this course include developing computer skills, using digital resources effectively, analyzing data, retrieving information from online sources and evaluating this information in social work practice. Basic Information Technologies course aims to help students contribute to contemporary social work practice by supporting social workers to use information technologies effectively, provide better services to clients, and adapt to the digital transformation in social work practice.

Teaching Method(s) : Overhead projector and slides, computer assisted lecture+practice

Evaluation Method: Midterm exam (20%), practice (20%) and final exam (40%).

SHL101-Review in Social Work Settings (1-2-2) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL101- Review in Social Work Settings is a course that aims to provide social work students with the skills to understand, evaluate and analyze the various settings in which social work practice takes place. This course provides students with a practical perspective to understand how social work is practiced in different fields of social work and in various institutions and organizations. Review in Social Work Settings provides students with the opportunity to examine the places where social work services are provided, the organizational structures of these services and various social work practices. In this context, interactive learning methods such as site visits, case studies and guest speakers are used to understand the interactions in social work settings, client needs and the role of the professional social work team. Review in Social Work Settings aims to provide students with a basic competence in understanding the practical aspects of social work, gaining experience in a professional context and understanding how social work interacts in society. This course is designed to prepare social work students for their profession and to enable them to work effectively in different social work settings. In the content of this course, institutions and organizations serving in a different field are visited every week in order to gain an introduction to social work and social service organizations. Each student prepares an individual report on these visits and the information received during these visits. Following the practical hours with institution visits, one-hour theoretical lectures are held where the theoretical evaluation is made.

Assessment Method: Midterm exam (40%), final exam (60%).

SHL103-Introduction to Sociology (3-0-3) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory



Course Content: SHL103-Introduction to Sociology is a course designed to provide social work students with an understanding of social phenomena, group dynamics and social processes. This course aims to help social work professionals understand the social context and assess client needs from a more holistic perspective. Introduction to Sociology provides students with the opportunity to understand the social institutions, processes of social change and social inequalities that constitute the basic structure of society. In this context, sociological theories and concepts are examined to understand how social work practice interacts with social dynamics. Course content emphasizes how sociological perspectives can be used to understand the roles and responsibilities of social work, assess client systems, and plan social work interventions more effectively. Introduction to Sociology course aims to provide social work students with the ability to think more deeply in the social context. The sociological perspective gained from this course will contribute to social work professionals becoming more aware and knowledgeable in dealing with various social problems and providing more effective support to their clients.

Teaching Method(s): Lecture, question-answer, discussion

Assessment Method: Midterm exam (40%), final exam (60%)

SHL105-Basic Concepts of Law (3-0-3) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL105-Basic Concepts of Law is a course that aims to provide social work students with the opportunity to understand the basic principles and concepts of law, to evaluate legal responsibilities in social work practice and to gain basic knowledge of the legal system. This course aims to support social workers to provide services in accordance with ethical and legal standards. Basic Concepts of Law provides students with a broad perspective on legal concepts, basic legal principles and legal issues related to social work. Course content covers legal challenges that may be encountered in social work practice, client rights and protection, confidentiality, mandated intervention and other legal issues. It also focuses on developing social work professionals' skills in understanding, interpreting and applying legal documents.



Basic Concepts of Law course aims to provide social work students with the skills to understand legal processes and address legal issues. Upon completion of this course, social workers will better develop their ability to respect client rights, comply with ethical norms, and act effectively within the legal framework.

Teaching Method(s): Lecture, question-answer, discussion

Assessment Method: Midterm exam (40%), final exam (60%)

SHL107-Introduction to Social Work (3-0-3) ECTS 5

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL107-Introduction to Social Work is a course that aims to provide social work students with a comprehensive introduction to the basic principles, goals, values and practice areas of social work. In this course, students have the opportunity to understand the history and evolution of social work and its purpose to meet societal needs. Introduction to Social Work covers the broad spectrum of social work, focusing on the basic concepts, ethical standards and professional responsibilities of social work. Course content focuses on understanding how social work interacts with individuals, groups and communities, how it contributes to social change, and how it intervenes to solve social problems. Introduction to Social Work aims to provide students with a foundation for embracing the broad spectrum of social work and understanding how social workers can bring about effective change in society, while teaching the basic principles, values and ethics of the social work profession.

Teaching Method(s): Lecture, question-answer, discussion

Assessment Method: Midterm exam (40%), final exam (60%)

SHL109-General Economics (3-0-3) ECTS 4

Course Level: Undergraduate



Course Type: Compulsory

Course Content: SHL109-General Economics is a course that aims to provide social work students with basic knowledge in understanding economic processes, evaluating the economic context of social services and understanding the economic dimensions of social work interventions. This course aims to develop students' understanding of economic principles and their ability to understand the financial and economic interactions of social work. General Economics course aims to introduce students to micro and macroeconomic concepts and to provide them with analytical skills to evaluate the economic impact of social work practices and policies. The course content covers topics such as basic principles of economic systems, demand and supply, pricing, competition and economic sustainability of social work interventions. General Economics course aims to provide social work students with a foundation for understanding economic issues and evaluating how social work practice interacts with economic realities. By providing students with the skills to evaluate the economic aspects of social work, this course aims to contribute to the development of sustainable and effective solutions for social work professionals.

Teaching Method(s): Lecture, question-answer, discussion

Assessment Method: Midterm exam (40%), final exam (60%)

AIT-Atatürk Principles and Revolution History (4-0-4) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: Collapse of the Ottoman Empire and the National Struggle: The weakening and collapse of the Ottoman Empire. Mondros Armistice and occupations. Mustafa Kemal's departure to Samsun and the start of the struggle for independence in Anatolia. War of Independence: The Battle of Sakarya and the Great Offensive. Treaty of Lausanne and the establishment of the Republic of Turkey. Proclamation of the Republic and Innovations: Proclamation of the Republic and laying the foundations of a secular, democratic and legal state. Transition of the Turkish alphabet to the Latin alphabet. Civil Code and other basic legal regulations. Principles of Atatürk: Basic principles of the Republic: Nationalism, Populism, Statism, Secularism, Revolutionism. Explanation and application of these principles. Social and Economic Reforms: Village Institutes and modern education. Turkey's industrialization process. Second Five Year Development Plan. Foreign Policy: The effects of the Treaty of Lausanne. Developments in Turkey's international relations. Atatürk's Death and Legacy: Atatürk's death and subsequent developments in Turkey. Atatürk's legacy and its impact. The course content should aim to provide students with the ability to understand and evaluate the basic principles, history and impact of the Turkish revolution. It should also include hands-on learning methods to help students develop critical thinking skills and understand how these historical processes played a role in the formation of modern Turkey.

Teaching Method(s): Online

Evaluation Method: Midterm exam (40%), final exam (60%).

SHL102-Report Writing and Presentation Skills (2-0-2) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory



Course Content: SHL102-Report Writing and Presentation Skills is a course that aims to develop effective communication, professional writing and presentation skills in social work students. This course aims to provide students with a comprehensive understanding of how to systematically document, report and present information in social work practice. Report Writing and Presentation Skills introduces students to the essential elements of an effective report, including the correct use of sources, organization of information, encouraging analytical thinking and reporting processes. In addition, this course aims to provide students with the skills to understand presentation techniques, use visual aids effectively, and convey information in a professional setting. Report Writing and Presentation Skills course plays an important role in ensuring that social workers are equipped with strong communication skills. By reinforcing written and oral communication skills, it aims to enhance students' ability to effectively convey information and document social work interventions in a professional manner. This course aims to contribute to students' professional development by giving them the confidence to share their achievements and findings within social work practice.

Teaching Method(s): Lecture, Homework, Question and Answer

Assessment Method: Midterm exam (40%), final exam (60%).

SHL104-Turkey's Social Structure (2-0-2) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL104-Turkey's Social Structure is a course that aims to provide social work students with the opportunity to understand the social dynamics, social structure and cultural diversity in Turkey. This course aims to provide students with the opportunity to examine the social, cultural and economic evolution of Turkey from its history to the present, and to contribute to students' understanding of various social factors that they may encounter in social work practice. Turkey's Social Structure aims to provide students with the skills to understand, evaluate and analyze the factors affecting the social structure of Turkey. By addressing issues such as demographic structure, social classes, ethnic groups, gender roles, economic inequalities, this course allows students to understand the dynamics affecting the social fabric of



Turkey. It also aims to assess cultural diversity and promote inclusive social work practice. Turkey's Social Fabric course aims to provide social work students with an understanding of Turkey's various social problems and to develop effective intervention strategies to address these problems. This course provides students with a basic background in understanding how social work can adapt to the complex social structure of Turkey.

Teaching Method(s): Lecture, Homework, Question and Answer

Assessment Method: Midterm exam (40%), final exam (60%).

Language of Education: Turkish

SHL106-Introduction to Psychology (3-0-3) ECTS 5

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL106-Introduction to Psychology is a course that aims to provide social work students with an understanding of basic psychological concepts and the skills to use these concepts effectively in social work practice. This course aims to provide students with a general understanding of psychology in terms of human behavior, emotional processes and cognitive functioning. Introduction to Psychology provides students with an understanding of basic principles of psychology as well as a foundation for understanding how to integrate psychological theories and approaches in interventions within social work practice. This course emphasizes the importance of psychology in social work practice by addressing topics such as human behavior, personality development, emotional health, stress and crisis interventions. Introduction to Psychology course aims to provide students with the skills to assess individuals' psychological needs, understand emotional states and plan social work interventions more effectively. This course provides students with the basic psychological knowledge and skills necessary for social workers to work more empathetically with individuals.

Teaching Method(s): Lecture, question-answer, discussion

Assessment Method: Midterm exam (40%) and final exam (60%).

SHL108-Introduction to Philosophy (3-0-3) ECTS 5

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL108-Introduction to Philosophy is a course that aims to provide social work students with a basic knowledge in understanding philosophical thought, developing critical thinking skills and understanding ethical issues. This course aims to provide students with an understanding of the history of philosophical thought, main currents and basic concepts, as well as to develop their ability to understand and evaluate philosophical approaches in social work practice. Introduction to Philosophy aims to teach students how to approach philosophical questions, how to analyze systems of thought and how to approach ethical issues sensitively. This course aims to contribute students to understand the basic ethical principles and values of social work and to think about how to integrate these values into daily practice. Introduction to Philosophy course aims to provide students with a deeper understanding of ethical issues, value conflicts and decisions in social work practice that social workers may face. This course contributes to students' ability to cope with challenging situations in social work practice by providing them with critical thinking skills.

Teaching Method(s): Lecture, Question and Answer, Discussion, Homework

Assessment Method: Midterm exam (40%) and final exam (60%)

Education Language: Turkish

SHL110-Introduction to Statistics (4-1-4) ECTS 5

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL110-Introduction to Statistics is a course that aims to provide social work students with the skills to understand statistical methods, analyze data and use this information effectively in social work practice. This course aims to teach students basic statistical concepts, data collection methods and statistical analysis techniques. Introduction to Statistics aims to provide students with the skills to understand, interpret and analyze data sets that they may



encounter in social work practice. This course aims to provide the basic skills necessary to develop statistical thinking, evaluate the impact of social work interventions and analyze data in research studies. Introduction to Statistics course aims to teach students the basic statistical knowledge necessary to contribute to research projects in the field of social work and to understand the results of these projects. This course helps students develop a strong analytical acumen, while enabling them to make informed decisions in the processes of planning and evaluating social work interventions.

Teaching Method(s): Lecture, question-answer, discussion

Assessment Method: Midterm exam (40%), final exam (60%).

ELECTIVE COURSES

SHL112-Basic First Aid (2-0-2) ECTS 3

Course Level: Undergraduate

Course Type: Elective

Course Content: Basic Principles and Definitions of First Aid: Definition and purpose of first aid. Stages and basic principles of first aid. Basic First Aid Skills: Consciousness control and respiratory control. Heart massage and artificial respiration techniques. Control of bleeding and wound care. Injuries and Emergencies: Fractures and sprains. Burns and frostbite. Electric shocks and other emergencies. Poisoning and First Aid: Poisoning symptoms and emergency response. Different types of poisons and methods of dealing with them. First Aid in Natural Disasters: First aid in natural disasters such as earthquakes, floods, fires, etc. Emergency evacuation and relief plans for disaster situations. First Aid in Children and the Elderly: Emergency scenarios specific to children and the elderly. Application of basic first aid skills in these groups. First Aid Equipment and Supplies: Contents of a basic first aid kit. Use and care of first aid equipment. First Aid Training and Certification: The importance of first aid training. Simulations and practical applications to provide participants with basic first aid skills. This course aims to provide students with basic first aid knowledge and skills. Practical applications, scenarios and simulations aim to enable students to intervene effectively and quickly in emergency situations. It also includes effective communication strategies to create health



awareness in the community and to provide students with leadership skills in emergency situations.

Teaching Method(s) : Full learning model, question-answer, demonstration, case study

Assessment Method: Midterm exam (40%) and final exam (60%).

SHL114-Sign Language (2-0-2) ECTS 3

Course Level: Undergraduate

Course Type: Elective

Course Content: SHL114-Sign Language is a course that aims to provide social work students with the skills to communicate effectively with hearing impaired individuals. This course aims to provide students with the skills to communicate with hearing impaired individuals, understand their needs and provide effective support in social work practice. It also aims to increase the access of hearing impaired individuals to social work services and enable social workers to work more effectively with this population. Sign Language teaches basic sign language, including basic expressions and sentence structures used in communication with hearing impaired individuals. There is also content on understanding the cultural and social context of sign language. This course aims to enable social workers to communicate sensitively and effectively in situations where they encounter individuals with hearing impairments. The Sign Language course introduces social work students to various communication strategies and ethical issues to consider when working with hearing impaired individuals. In this way, social workers can work in better collaboration with deaf individuals and have a more positive impact on their lives.

Teaching Method(s): Lecture, question-answer, discussion

Evaluation Method: Midterm exam (20%), practice (20%) and final exam (60%).

Language of Education: Turkish

SHL116-Music (2-0-2) ECTS 3

Course Level: Undergraduate



Course Type: Elective

Course Content: Basic Principles of Music: Basic principles of music such as melody, rhythm, harmony and tonality. Basic note and chord structures. Historical Development of Music: An overview of the history of music from antiquity to the present. Different musical periods and prominent composers. Basic Music Theory: Note reading and writing skills. Basic music terms and symbols. Different Music Genres: Characteristics of different types of music such as classical music, pop, rock, jazz, folk music. Traditional music developed in different cultures. Music Analysis and Criticism: Analysis of musical works. Music criticism and aesthetic evaluation. Social and Cultural Role of Music: The role and effects of music in society. The importance of music as cultural expression. Music and Technology: Digitalization of music and its relationship with technology. Digital instruments and music production. Music Education and Performance: Basic music education methods. Practices to improve students' instrumental or vocal performance skills. This course aims to provide students with basic knowledge and a broad perspective on music. At the same time, it offers students the opportunity to make connections between different genres of music, develop critical thinking skills and increase their ability to have knowledge about music. Music class also offers students the opportunity to develop their creativity and understanding of music as an art form.

SHL118-Healthy Life (2-0-2) ECTS 3

Course Level: Undergraduate

Course Type: Elective

Course Content: World Health Organization / Region / Turkey, World Health Report 1996, Target 21, Health System in Turkey, Health Related Concepts - Health Definitions, Determinants of Health, Concept: Health Promotion, Health Protection Levels, Nursing and Health Promotion, Health Education, Health Promotion Models (Health Belief Model, Health Promotion Model), Universal Health Declarations for Health Protection and Promotion, Health Promotion: Current Situation in the World and in Turkey, Health Promotion Specific to Developmental Periods.

Course Content: Basic concepts of entrepreneurship, characteristics of entrepreneur and necessary skills, women entrepreneurship, entrepreneurship ethics in Turkey, organizational culture, communication and entrepreneurship network, entrepreneurship and franchise, local entrepreneurship, can everyone be an entrepreneur, entrepreneurship finance, business plan concept and its elements (market research, marketing plan, production plan, management plan, financial plan), business plan examples, definition, characteristics and classification of project, project management and organization, logical framework approach, budgeting in project management, control and reporting in project management, project risk management.

Teaching Method(s): Lecture, question-answer, demonstration

Assessment Method: Midterm exam (40%) and final exam (60%).

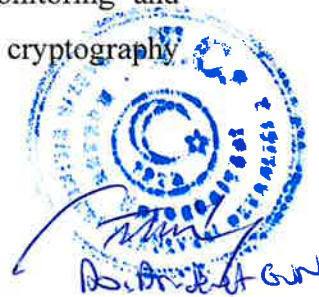

SHL122-Cyber Security (2-0-2) ECTS 3

Course Level: Undergraduate

Course Type: Elective

Course Content: This course will cover the fundamentals of cyber systems and information security. It provides a strong foundation in cyber systems and information security. The objectives of this course are security and risk management, asset security, identity and access management, security assessment and testing, cryptography, penetration testing, mobile security, social engineering, legal and ethical issues. The cyber security problem, basic concepts of cyber security, history of the internet, cyber security elements and processes, cyberspace and basic characteristics of cyberspace, cybercrimes; identity theft and impersonation, hacking, terrorism and organized crime in cyberspace, cyber law, sources of cyber attacks, monitoring and preventing advanced cyber attacks, types of cyber attacks, cyber defense systems, cryptography.



applications, electronic security, cyber security standards, information security and risk management, ISO/IEC-27032 cyber security guidelines, current issues in cyber security and review.

Teaching Method(s): Lecture, question-answer, discussion

Evaluation Method: Midterm exam (40%), final exam (60%).

SHL124-Technology Literacy and Information Ethics (2-0-2) ECTS 3

Course Level: Undergraduate

Course Type: Elective

Course Content: Conceptual approach to ethics, ethical principles, types of ethics, information technologies and computational thinking; problem solving concepts and approaches; algorithms and flowcharts; computer systems; basic concepts of software and hardware; basics of operating systems, current operating systems; file management; utilities (third party software); word processing programs; calculation/table/graphics programs; presentation programs; desktop publishing; database management systems; web design; internet use in education; communication and collaboration technologies; safe internet use; information ethics and copyrights; effects of computers and internet on children/youth.

workers/application, occupational diseases, ways of protection from occupational diseases, occupational accidents, ways of protection from occupational accidents, work and workplace safety, organizations related to social security and occupational health, worker nutrition and its relationship with the workforce / application.

TRD-Turkish Language (4-0-4) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: What is language? The place and importance of language in the life of a nation as a social institution, language-culture relationship, the place of Turkish language among the world languages, the development and historical stages of Turkish language, the current status and spread areas of Turkish language, sounds in Turkish, classification of sounds, sound features of Turkish, syllable knowledge, stress, spelling rules, punctuation marks, construction suffixes, inflection suffixes, the use of adverbs and prepositions. Sentence knowledge, sentence analysis, written and oral expression, expression disorders, rules to be followed in the preparation of scientific writings (report, article, communiqué, etc.), based on sample texts selected from Turkish and world literature, the development of the student's ability to speak and write correctly and beautifully and rhetorical practices related to this.

Teaching Method(s): Lecture, question-answer, discussion.

Evaluation Method: Midterm exam (40%), final exam (60%).

SHL201-Research Methods in Social Work-1 (3-0-3) ECTS 3

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL201-Research Methods in Social Work-1 course is a basic course that aims to develop the ability to conduct effective and scientific research in the field of social work. This course aims to strengthen the research skills of social workers so that they can produce and evaluate solutions to the social problems they face. The course content covers the basic steps and methods of research processes in social work. It also emphasizes the principles of research ethics such as ethical issues, data reliability and validity, and focuses on helping students conduct research in



accordance with ethical standards. Research Methods in Social Work-1 course provides students with basic knowledge in understanding and applying quantitative and qualitative research methods. This course aims to increase the capacity of social workers to bring a scientific approach to the problems they face in the field and to produce effective solutions.

Teaching Method(s): Lecture, question-answer, discussion.

Assessment Method: Midterm exam (40%), final exam (60%).

SHL203-Human Behavior and Social Environment I (4-0-4) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL203-Human Behavior and Social Environment I is a basic course that aims to provide social work students with the skills to understand human developmental processes and their interaction with the social environment. This course offers an examination of the early stages of an individual's life, starting from infancy, childhood and adolescence. The course covers the physical, cognitive, emotional and social development of the individual and how these processes are shaped by the social environment and interaction factors. Key developmental milestones in infancy, childhood and adolescence, the individual's personality formation, relationship building skills, social identity development, and challenges specific to the life stages are among the focal points of this course. Human Behavior and Social Environment I provides students with an analytical framework for understanding the various social issues and challenges faced during these critical periods of an individual's life. It also includes practical skills to help social workers understand how they can intervene to provide effective support to individuals during these periods.

Teaching Method(s): Lecture, question-answer, discussion.

Assessment Method: Midterm exam (40%), final exam (60%).

SHL205-Social and Cultural Anthropology (3-0-3) ECTS 4

Course Level: Undergraduate



Course Type: Compulsory

Course Content: SHL205-Social and Cultural Anthropology course provides students with a comprehensive perspective to understand social structures, cultural processes, and diverse ways of life of human communities. The course introduces students to the basic concepts and methods of anthropology and provides in-depth analysis of different cultures through ethnographic studies. Topics such as social organization, the role of language, rituals, belief systems, social change and cultural interaction are the focus of the course. The course also aims to develop an anthropological way of thinking and to provide students with the skills to interact more sensitively with cultural diversity, providing them with a basis for understanding and evaluating different cultures and for better communicating with cultural diversity.

SHL207-Social Problems (2-0-2) ECTS 3

Course Level: Undergraduate

Course Type: Compulsory

Course Description: SHL207-Social Problems provides students with a framework for understanding the complex and diverse social problems facing today's societies. This course provides students with the opportunity to understand the definition, origins, and impacts of social problems, focusing on strategies for dealing with and solving them. A variety of issues such as unemployment, poverty, educational inequality, racism, gender inequality, environmental problems, etc. are addressed, providing students with analytical thinking skills related to these problems. In addition, by focusing on concepts such as social policy, social change, civil society engagement, students gain knowledge and understanding of how they can make an impact at the societal level in order to deal with these problems effectively. Social Problems course offers an interactive learning experience to provide students with the ability to consider multiple perspectives and interactions when addressing social issues.

This hands-on approach provides students with the opportunity to strengthen skills that are fundamental to social work practice, such as empathy, problem solving and group collaboration. Furthermore, the course promotes intercultural understanding with the aim of enhancing their ability to better interact with and support diverse groups within society. Creative Drama aims to strengthen interpersonal relationships and contribute to social change by providing students with an innovative approach to social work.

SHL219-Volunteering Studies (1-2-2) ECTS 4

Course Level: Undergraduate

Course Type: Elective

In this course, students develop the skills needed to understand the social impact of volunteer work and to participate effectively in this work. The course content focuses on the planning, implementation and evaluation of volunteering projects in different social work contexts. In addition, students are introduced to ethical responsibilities in volunteer work, intercultural interaction, sensitivity to community needs and participation in social change processes.



Through practical experiences, students are given the opportunity to understand how volunteer work can make a difference at the individual and community level. Volunteerism Studies course aims to provide social work students with a strong foundation to reinforce the values on which their profession is based and their commitment to their communities. This course aims to provide students with not only theoretical knowledge but also practical skills to take an active role in volunteer work.

SHL221-Professional English-I (2-0-2) ECTS 4

In addition, their ability to understand and interpret commonly used literature in the field of social work is emphasized. The course content is designed to enable students to articulate social work processes and interactions more effectively. Through both written and oral communication practice, case studies and role plays, students strengthen their professional English skills while learning how to use it in a social work context. Professional English-I aims to provide social work students with the necessary language skills to develop their ability to communicate effectively in a global perspective and to participate in social work activities internationally.

It provides in-depth knowledge of quantitative and qualitative data collection techniques, data analysis, research ethics, literature review and research design. In addition, students are provided with the skills to effectively communicate, report and present research results. Research Methods in Social Work-II aims to increase the ability of social work professionals to make scientifically based decisions and emphasize the importance of research in professional practice. This course offers a comprehensive education designed to provide students with the skills needed to build a strong research foundation in social work practice.

Teaching Method(s): Lecture, question-answer, discussion.

Assessment Method: Midterm exam (40%), final exam (60%).

Education Language: Turkish

SHL204-Human Behavior and Social Environment II (4-0-4) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: This follow-up course focuses on the stages of human life in adulthood and old age. It is a program that teaches social work students the basic concepts needed to understand, evaluate and interact with the behavior of individuals and groups at this stage of life. In this course, students are provided with the opportunity to examine the effects of the social environment on individual behavior, to develop awareness of social justice and social inequality issues, and to develop their ability to plan intervention strategies. The course combines



theoretical frameworks and practice to understand how human behavior is influenced by social, cultural and economic factors. It also provides students with the opportunity to learn and effectively apply a variety of social work intervention methods and strategies. Human Behavior and Social Environment II aims to strengthen social work practitioners' abilities to understand client needs and identify appropriate interventions. This course provides an education designed to help social work professionals develop critical thinking and evaluation skills to address human behavior and the social environment as a whole.

SHL206-Social Work Theories and Approaches I (4-0-4) ECTS 4

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL206-Theories and Approaches to Social Work I course is a course that introduces social work students to the processes of working with individuals and basic theories. This course provides students with the opportunity to develop their understanding and application skills of social work interventions at the individual level. Topics covered in the course include basic theoretical frameworks, therapeutic approaches, intervention strategies and ethical principles used in social work interventions with individuals. Theories and Approaches to Social Work I aims to strengthen social workers' ability to empathize with individuals, identify needs, provide support and promote change. Topics emphasized in this course include individual intervention theories, psychosocial assessment, counseling skills, crisis intervention, and the interaction of the individual with his/her social environment. In addition, students are given practical experience in understanding and applying different models of individual intervention. Theories and Approaches to Social Work I aims to provide social work students with the basic knowledge and skills for effective and ethical social work practice at the individual level.

This course provides students with the opportunity to develop their understanding of the principles of public administration and their ability to contribute to the effective planning and implementation of public services. It also provides a strategic perspective on how social work can be more effectively positioned in the public sector, how it can be involved in the formulation of social policies, and how social workers can contribute to the delivery of public services. Public Administration and Social Work stands out as an important course that aims to provide social work students with the ability to integrate both social work principles and key issues in public administration.

Students will gain the skills to understand inequalities between individuals from various social groups, promote social justice and develop a human rights-centered perspective in social work practice. This course will strengthen sensitivity to human rights as one of the core principles of social work, aiming to enhance the ability of future social work professionals to provide empowering and just services.

ELECTIVE COURSES**SHL214-City and Urbanization (2-0-2) ECTS 4**

Course Level: Undergraduate

Course Type: Elective

Course Content: SHL214-Urban and Urbanization is a program that offers social work students the opportunity to understand the dynamics of cities, urban transformation, social justice, social inequality and urbanization processes. In this course, students are provided with basic information on the social, economic and cultural impacts of urbanization processes, urban planning and policies, urban development projects, strategies for dealing with urban problems such as housing problems and urban poverty. In addition, the roles and interactions of different stakeholders (communities, local governments, non-governmental organizations) involved in urbanization processes are emphasized and the potential of social workers to contribute to urbanization processes is emphasized. This course aims to provide students with the knowledge and skills to understand the social problems faced by individuals and communities living in

urban areas, to evaluate various urban policies and practices in terms of social work, and to integrate social work interventions into urban transformation projects. SHL214 offers a comprehensive education to develop the analytical thinking and intervention skills necessary for social workers to produce fair, equitable and sustainable solutions in urbanization processes.

Teaching Method(s): Lecture, Homework, Question and Answer

Assessment Method: Midterm exam (40%), final exam (60%).

SHL216-Industrial Social Work (2-0-2) ECTS 4

Course Level: Undergraduate

Course Type: Elective

Course Description: SHL216-Industrial Social Work is a program that provides social work students with the opportunity to understand the social dynamics in industry and workplace settings, to enhance employee well-being, and to develop their ability to intervene in workplace social problems. In this course, students are provided with in-depth knowledge on the basic principles of industrial social work, industrial relations, occupational health and safety, workplace stress, employee motivation, diversity management in the workplace. In addition, practical skills are gained on how industrial social workers can respond to the psychosocial needs of employees in workplaces, strengthen workplace relationships and find solutions to social problems in the workplace. Industrial Social Work aims to strengthen the knowledge, skills and ethical understanding necessary for social workers to play an effective role in industry and business. Topics emphasized in this course include social responsibilities in the workplace, employee rights, workplace communication, workplace justice, and managing social change processes in the workplace. Industrial Social Work aims to provide students with a foundation to understand the role of industrial social work in the world of work and to be equipped to understand how to effectively implement social work interventions in the workplace.

Teaching Method(s): Lecture, Homework, Question and Answer

Assessment Method: Midterm exam (40%), final exam (60%).

SHL218-Civil Society Organizations and Social Work (2-0-2) ECTS 4

Course Level: Undergraduate

Course Type: Elective

Course Content: SHL218-Civil Society Organizations and Social Work is a program that aims to provide social work students with the skills to understand the role of civil society organizations, to establish effective collaboration with these organizations and to contribute to social change. In this course, students are provided with basic information about the structure, mission and vision of civil society organizations, strategic planning, governance, resource development, community mobilization, advocacy and collaboration between civil society organizations and social work professionals. In addition, students' practical skills are enhanced by emphasizing the potential impact of civil society organizations in the field of social work, developing projects that are sensitive to community needs, and communicating effectively with civil society organizations. SHL218 aims to provide social workers with the knowledge and skills needed to understand how they can serve their communities through civil society organizations and to lead social change through collaboration with these organizations. Topics emphasized in this course include the impact of civil society organizations in the field of social work, advocacy strategies, social change projects, sustainable development and social justice. SHL218 aims to provide students with a strong foundation for effective collaboration with civil society organizations and effective solutions to social problems.

Teaching Method(s): Lecture, Homework, Question and Answer

Assessment Method: Midterm exam (40%), final exam (60%).

SHL220-Sexual and Reproductive Health (2-0-2) ECTS 4 Course

Level: Undergraduate

Course Type: Elective

Course Content: SHL220-Sexual and Reproductive Health course focuses on a program that aims to provide social work students with in-depth knowledge and skills in sexual and reproductive health. In this course, students are provided with basic information about

sexuality, reproductive health, sexually transmitted infections, family planning, sexual harassment and abuse. In addition, students gain practical skills to understand and develop social workers' intervention strategies in sexual health services, sexual identity and orientation, sex education, fertility issues. Sexual and Reproductive Health aims to enable social workers to understand how to work effectively in areas such as promoting individuals' sexual health, intervening in reproductive health issues, raising awareness at the community level, and increasing access to sexual health services. Topics emphasized in this course include integration of sexual health services with social work practice, cross-cultural sexual health services, sexual health education, and sexual health promotion strategies. Sexual and Reproductive Health aims to provide students with a deep understanding of sensitivity, ethical responsibilities and gender issues in the field of sexual and reproductive health, strengthening the ability of social work professionals to effectively serve in this important health area.

Teaching Method(s): Lecture, Homework, Question and Answer

Assessment Method: Midterm exam (40%), final exam (60%).

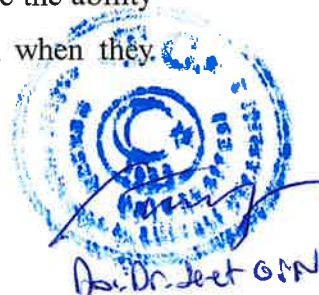

It also includes interactive language exercises and simulations to provide students with practical skills such as writing professional reports, making presentations and participating in professional meetings. Professional English-II emphasizes to social work students the importance of the English language in the social work profession and aims to provide them with the skills to communicate effectively in a professional context. The course provides students with specialized language skills to improve their written and oral expression skills on social work related topics. In this way, it supports them to have the ability to communicate effectively at an international level in the field of social work when they



graduate.

SHL226-Information Technologies in Social Work (2-0-2) ECTS 4

Course Level: Undergraduate

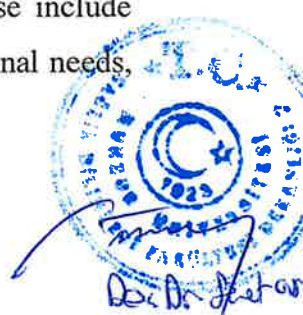

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL302-Applied Research in Social Work-II course is a comprehensive program that aims to teach applied research methods and analysis techniques to social work students. In this course, students are provided with basic knowledge on examining practical problems in the field of social work, evaluating the effects of social policies, evaluating intervention programs and understanding client needs. In addition, students are provided with practical skills in quantitative and qualitative research methods, data collection tools, ethical issues and effective communication of research findings. SHL302 aims to develop the research skills of social workers and to ground social work practice on scientific foundations. Topics emphasized in the course include formulating research questions, conducting a literature review, creating a research design, analyzing data, interpreting findings, and presenting research results in written and oral form. Applied Research in Social Work-II course aims to provide students with a strong foundation in using research skills to strengthen social work practice and contribute to social change. 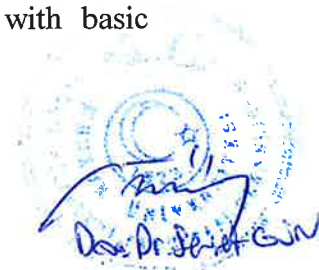

Practical skills such as medical and psychiatric social work intervention strategies, effective communication with patients and families, patient assessment, rehabilitation planning and resource management are also included. Medical and Psychiatric Social Work course aims to enable social workers to work effectively in health and psychiatric services. Topics emphasized in the course include medical terminology, social impact of illness, coping strategies for chronic illness, psychiatric social work models, and multidisciplinary collaboration in health care. 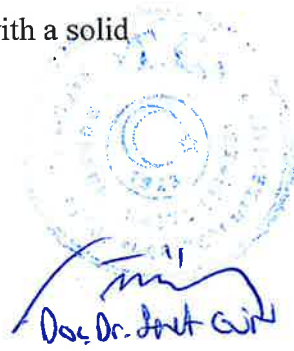

SHL409-Social Work in Disasters (2-0-2) ECTS 4

Course Level: Undergraduate

Course Type: Elective

Course Content: SHL409-Social Work in Disasters course is a program that aims to provide social work students with the skills to intervene effectively in disaster situations. In this course, students are provided with basic information on the social effects of disasters, emergency management, crisis intervention, building community resilience, post-disaster recovery processes and pre-disaster planning. In addition, practical skills such as social work intervention strategies in disasters, communication with disaster victims, emergency planning and resource management are also included in the course. Social Work in Disasters course aims to enable social workers to respond quickly and effectively in disasters. Topics emphasized in the course include pre-disaster planning, emergency response, community support systems, post-disaster psychosocial support and long-term rehabilitation. Social Work in Disasters course aims to strengthen social workers' skills to understand, support and empower individuals, groups and communities affected by disasters. This course aims to provide social work students with the skills to intervene effectively in disaster situations.

Assessment Method: Midterm exam (40%), final exam (60%).

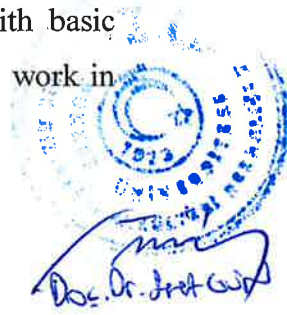

SHL411-Forensic Social Work (2-0-2) ECTS 4 Course

Level: Undergraduate

Course Type: Elective

Course Content: SHL411-Forensic Social Work course is a program that aims to provide social work students with an understanding of the role of social work in the judicial system and to work effectively in judicial processes. In this course, students are provided with basic information on topics such as crime and penal systems, social work in courts, social work in



detention centers and prisons, forensic evaluation, social impact of court decisions. In addition, practical skills such as forensic social work intervention strategies, counseling in court processes, working with crime victims, community sentencing and crime prevention are also included in the course. Forensic Social Work course aims to enable social workers to understand the social needs of individuals in forensic processes and to provide effective solutions to these needs. Topics emphasized in the course include the ethical and legal framework of forensic social work, empathy with crime victims, forensic assessment and evaluation of court decisions from a social work perspective. Forensic Social Work course focuses on social workers developing a strong professional identity in the forensic system and contributing to forensic processes from a social work perspective. This course aims to provide social work students with a strong foundation in forensic social work and effective intervention strategies.

SHL413-Anti-Printing Application (2-0-2) ECTS 4

Course Level: Undergraduate

Course Content: SHL413 - Anti-Oppression Practice course is a program that aims to provide social work students with the skills to effectively combat oppressive and discriminatory practices. In this course, students are provided with basic information about the types of social oppression, anti-discrimination, social justice, equality and human rights. Practical skills such as anti-oppression social work intervention strategies, advocacy, campaign management, community awareness raising and change management are also included. Anti-Oppression Practice course aims to enable social workers to take leadership in the fight against oppression, discrimination and social injustices and to strive for social change. Topics emphasized in the course include analysis of social inequalities, advocacy strategies, diversity management, theories of social change, and cultural sensitivity. Anti-Oppression Practice course supports social workers to act ethically and effectively in the fight against oppressive systems. This course aims to provide social work students with a strong foundation in anti-oppression practice and effective intervention strategies.

SHL415-Child Neglect - Abuse and Social Work (2-0-2) ECTS 4

Course Level: Undergraduate

Course Type: Elective

Course Content: SHL415-Child Abuse, Neglect and Social Work course is a program that aims to develop social work students' skills in understanding, preventing and intervening in situations of neglect and abuse faced by children. In this course, students are provided with basic information on child rights, definition of child abuse and neglect, risk factors, working with abused children, protective services, court processes and respect for children's rights. In addition, practical skills such as social work intervention strategies in combating child abuse and neglect, child assessment, family counseling, protective service planning and child welfare policies are also included in the course. Child Abuse, Neglect and Social Work course aims to enable social workers to act effectively to protect the safety and well-being of children. Topics emphasized include types of child abuse, the role of protective services, social work in court processes, child support networks, and intervention strategies that respect children's rights. Child Abuse, Neglect and Social Work course supports social workers to understand the processes of working with children and to serve ethically in this field. This course aims to provide social work students with a strong foundation and effective intervention strategies in the field of child neglect and abuse.

SHL402-Social Work Practice II (2-28-16) ECTS 30

Course Level: Undergraduate

Course Type: Compulsory

Course Content: SHL402-Social Work Practice II course includes an intensive practicum program that aims to provide social work students with field experience. This course provides students with the opportunity to apply their theoretical knowledge in practice, develop their professional skills and try various intervention strategies in real-world social work scenarios. Students work in a designated agency 5 days a week throughout the semester, providing in-depth participation in the processes of understanding and solving complex issues in the field of social work. Social Work Practice II course provides students with the opportunity to understand the complexity of social work practice, interact with clients, implement intervention strategies, and understand the role of the social worker through field experience. During the internship, students collaborate with social work professionals in their organizations and take an active role in the process of providing services to clients. In addition, this semester-long practicum provides a platform for students to strengthen their professional identity, understand their ethical responsibilities, and evaluate the social impact of social work. Social Work Practice II course stands out as a course that aims to contribute to students' professional development through field experience
